 - i. What do you mean by enforce social hosts?
 1. We want to provide education on what policies are.
 - a. Prohibits those providing an environment that underage drinking is happening as well as providing underage students with alcohol.
 - ii. How many campus wide events do provide alcohol?
 1. What kind of programming is being held that separates 21+ from underage students.
 - iii. What was the internal debate about students being on the task force?
 1. We just debated on how to go about choosing students and making sure that we are not expecting too much from them.
 - iv. What is high-risk alcohol behavior: hospital visits, detox, BAC level, injuries related to alcohol, drinking and driving, damage because of alcohol.
 - v. Why are we taking away happy hours etc. because we are punishing the whole this way instead of just those who are abusing it?
 1. We don't want to demonize alcohol, but instead to challenge students to enjoy events without alcohol.
 - vi. Health and wellness floor at SJU?
 1. We are working on it again.
 - vii. How are we influencing businesses?
 1. We can't, but one of the proven strategies is to ban drink specials. We want to bring information to the city to consider.
 - viii. Has the new SJPD alcohol matrix influenced the way admin. Is looking at policies?
 1. This is looking at liquor licenses and penalties there.
 - ix. What is the matrix?
 1. It outlines what the violation is and what the penalty is and who will be taking care of it.
 - x. Is there significantly more cases at CSB/SJU rather than other campuses?

 1. Students are already binge drinking, so if we do these acts correctly what will they show? Research shows that it should make a positive impact not negative.
