III. RESEARCH, PUBLICATION, CONSORTIA:

- A. Research Projects, Publications, Addresses. Available upon request.
- B. Center for the Study of Local Government: Founder and director, 1968-72.
 Funded by Ford Foundation, Hill Family Foundation and Federal and State agencies. Inter-disciplinary and intercollegiate research mainly on small cities and rural community development.
 The Rural Criminal Justice Institute, a subsidiary to study non-metropolitan law enforcement problems, was added in 1969. The latter also served as the administrative arm and proposal writer for a fifteen county criminal justice planning region. Both appear to have been national "firsts".
 Aggregate spending on its own projects was probably close to \$2 million with millions more raised for its clientele. The Center provided research for college professors and students and internships for students. At its height 17 people were engaged.
- C. Consortia:
- 1) Co-founder and director of The Tri-College Honors Program, 1957-68. This was an inter-collegiate academic program between two private colleges and a public institution for faculty members and honor students. Funded by the Hill Family Foundation (St. Paul) (now, N.W. area Foundation), it provided seminar discussions, papers, travel, study, and consultants. Publication and library research were important components.
 - 2) Founder of the Central Minnesota Public Service Consortium in 1971 with funding coming from the Hill Foundation in 1972. It consisted of three colleges, two school districts, and the City of Saint Cloud and was designed for inter-collegiate cooperation in public service support and educational exchange. I left shortly after it was funded to assume the presidency of Saint Mary's College.

- (3) Saint Mary's College is the sister institution to Notre Dame and one of the older and more distinguished women's colleges in the U.S. In the Thirties it was one of only two Catholic institutions chosen by Dr. Conant in his survey study of American higher education. I took a three year leave of absence from Saint John's to reconstitute the college after its traumatic dismerger from Notre Dame U. in late 1971. I had served as a consultant to the college prior to my appointment.
 The college had lost almost 300 students out of 1700 and was facing a large deficit. During my term new recruiting and development departments were established; relations with Notre Dame were restored; three new academic majors launched (nursing, business, psychology) and enrollment and financial viability normalized.

- 3) Co-Founder of the Northern Indiana Consortium for Education. (NICE) which was funded by the Lilly Foundation in 1973. It consisted of the University of Indiana at South Bend; Bethel College; Saint Mary's College; and a post-secondary technical school. Its purpose was educational exchange and public service support.

IV. PLANNING, DEVELOPMENT, PUBLIC RELATIONS EXPERIENCE:

A. Development:

- 1) Organized first development department at Saint Michael's College to integrate and systematize the development function, 1976. In 1979, received honorable mention for publications by CASE and in 1981, national first place by CASE for consistent improvement in fund raising. Annual development income and endowment tripled.
- 2) Set up the development department at Saint Mary's College in 1972. Funding results escalated.
- 3) Organized the Development Department at Saint John's University in 1956. Appointed vice president for development, 1961-64 and 1974-76.
- 4) As assistant to the president at Mount Saint Scholastica College in 1952 I helped organize the Kansas Foundation of Private Colleges for joint fund raising.
- 5) In the Public Sector as Mayor of Saint Cloud, Minnesota, raised (in 1981 dollars) over \$26 million in new money from loans, grants and gifts to trigger a \$50 million program of public works. The City acquired one of the top reputations in the nation for fund raising relative to its size.
- 6) The Rural Justice Institute at St. John's which I directed from 1969-72 as administrative arm for a fifteen county planning district brought in millions for its constituents.
- 7) I have personally written successful funding proposals for Hill Family Foundation (N.W. Area F.); Lilly; Ford; Busch; Kellogg and a half dozen Federal and State agencies. My aggregate professional fund raising from discretionary sources would total over \$50 million.

B. Planning:

1) Private Sector:

Chaired the "Decade Ahead" Planning effort at Saint John's University (Mn.) and initiated planning at Saint Mary's College of Notre Dame (In.) and Saint Michael's College (Vt.)

Chaired two long range planning committees for the Lake Champlain Area Chamber of Commerce one of which resulted in Vermont's first Regional Council of Governments.

2) Public Sector:

Seven years on the Planning Commission of a 40,000 municipality during its most vigorous period of growth. Additionally as a mayor and simultaneously director of a college research center on government I was instrumental in developing new concepts of regional planning and putting them into practice. Likewise, I spent seven years on the Board of a large public school system during its period of maximum expansion.

2) Public Sector: (Cont'd.)

As a member of the three person Minnesota Municipal Commission over a two year period (a quasi-judicial body) the opportunity was presented to make planning decisions on detachment and annexation issues in an urbanizing countryside.

Over a ten year period I have lectured and consulted on community development problems in a dozen states.

C. Media Experience:

- 1) In 1946-47 I edited a weekly newspaper in Saint Cloud, Minnesota, after having worked for the AP and UP as a college based correspondent and during WWII as a part time navy correspondent. (I covered the Surrender of Formosa (Taiwan) 1945.)

I have served on the Board of Directors of: Minnesota Public Radio, 1975-76; a South Bend, Indiana, public TV station; and in 1977 on Vermont Educational TV. In 1980 I negotiated the location on my campus of Vermont Public Radio and supplied facilities for it.

I have had numerous TV and radio appearances in seven states including an hour long program with the Phil Donohue show. My professional projects have been featured in the New York Times; Chicago Sun, Chicago Tribune, Chicago Daily News; Life magazine; the National Observer; the Christian Science Monitor; Changing Times; the Miami Herald; The American City; Public Management, and many other publications at various times. Available.

I have published over sixty articles, monographs, research reports ranging from semi-popular (America) to serious (National Tax Journal) to semi-technical (12 volume Report on future of atomic energy plants in Minnesota). Editor of two books. In 1976 I was one of a half dozen commentators on urban development for a documentary film entitled: A Place to Live. Chicago and St. Cloud were two of twelve world cities featured. Film was entered in the Vancouver, British Columbia film festival.

VII. SPECIAL EDUCATION INTERESTS:

My conviction that education is a life-long process has drawn me into special education programs from pre-school through adult levels.

At the pre-school level I sat on the advisory board of a pre-school parent-child program in Saint Cloud, Minnesota, that has drawn national attention. In 1975 I wrote a funding proposal for this program which has resulted in supporting grants from the Busch Foundation of Minnesota and the Kellogg Foundation of Michigan.

In 1957 I was a co-founder of an adult great books program and in the same year started a junior great books program for exceptional junior and senior high school students in the diocesan school system. I subsequently directed this program for four years utilizing volunteer college students and housewives as moderators.

In 1958 with the first of two grants from the Hill Family Foundation I co-founded and then directed for ten years a joint honors program for three cooperating colleges in the Saint Cloud, Minnesota area, the Tri-College Program. Participants were: Saint Cloud State University; Saint John's University; and the College of Saint Benedict.

In 1971-72, I served as State Chairperson of the State Advisory Council on Continuing Education and Community Service.
