Schellinger Family Agrees to Permanently Protect Land for the Public

he Minnesota Department of Natural Resources Scientific and Natural Areas (SNA) Program has elected to purchase approximately 100 acres of mature oak forest from Francis and Karen Schellinger. This rolling tract of land is located approximately 3 miles south of Avon, Minnesota along the scenic Schuman Lake Road in Section 4 of Collegeville Township. The purpose of Scientific and Natural Areas assures examples of native ecosystems are preserved across the state. The land will be open to the public for nature observation, scientific research, and environmental education. SNAs are not open to motorized traffic or hunting. The SNA Program will continue to work with adjacent landowners in the area to provide long-term land protection options for their consideration.

The Francis and Karen Schellinger family has owned this land since about 1970. During these 36 years Francis, Karen, and their family have hunted, cut firewood, gathered mushrooms, practiced selective harvesting of timber (many of the trees are mature Red and White Oak) and otherwise enjoyed the natural setting that this 100 acres has offered. Located within the heart of the biologically significant Avon Hills and surrounded by tremendous natural beauty (amid increasing development), this property provides a core area of preservation that will hopefully encourage other landowners to similarly protect the

rural nature of the Avon Hills and seek options that benefit them, their family, their land, and future generations.

With a family of eight siblings the future of the Schellinger's property was very uncertain. Francis and Karen have always valued the natural beauty and integrity of the property and hoped for a way to preserve it while also providing a "fair" solution given the eight children in the family. The sale of the property for SNA designation allowed for it's preservation as well as providing a solution to how this property would be passed onto the siblings. Had this property not been designated as an SNA, the future of the property would likely been one of being broken up into smaller parcels in some way. Francis and Karen hope more people will look to the future, beyond their interests and lifetimes to preserve for future generations what we and others before us have been blessed to enjoy and experience.

The purchase of land by the MN DNR is just one option landowners have to permanently preserve their property. Conservation easements and cluster developments are additional options. Through this designation the Schellinger property will remain in its natural state and be protected from further development.

Stearns County Comprehensive Plan Update

<u>Purpose For The</u> Comprehensive Plan Update

Steams County has begun the process of updating their Comprehensive Plan. This will enable the county to better coordinate land use planning regulations.

Rapid growth and development in the eastern portion of Stearns County and changing demographics and agricultural practices in the western portion have created the need for a Comprehensive Plan update. The existing plan was revised in 1998 and no longer accurately reflects the needs of the County.

In order to assure that development occurs in a manner that realizes long-term benefits to the natural environment and local communities, the Comprehensive Plan will be used to coordinate plans and deliver services more efficiently.

What Has Been Done So Far?

Stearns County has hired a consultant team to lead them through the process of updating the comprehensive plan. This team will be responsible for facilitating meetings, developing new maps, analyzing existing

data, and preparing the updated comprehensive plan.

Stearns County has also formed a Citizen's Advisory Committee. This committee will play a key role in the development of the comprehensive plan and is made up of individuals that represent different interests within Stearns County. To date, the Citizen's Advisory Committee has met two times and will continue to meet until the final comprehensive plan has been adopted by the Stearns County Board of Commissioners.

There have also been a series of township cluster meetings held throughout the county. These meetings are designed to inform and educate township officials on good planning practices. The goal is to develop a comprehensive growth plan map for each township within Stearns County. There will be another round of township cluster meetings held this winter. How Can The Public Be Involved?

There will be open houses conducted for the public to attend. The open houses will update the public on what the comprehensive plan update is all about, where we are at in the process and, most importantly, provide an opportunity for the public to

give their input. They will be held at various locations and times around the county. The first round of open houses will be this fall and the second round will be this winter. Exact dates and locations have not been determined. Please watch the local newspapers or the Comprehensive Plan page of the Stearns County website (www.co. stearns.mn.us/Government/4643.htm) for notices of these open houses.

Public hearings will also be held towards the end of the Comprehensive Plan Update process, prior to the adoption of the final Plan. Completion of the Comprehensive Plan Update

The Comprehensive Plan Update is scheduled to be completed and approved by the Stearns County Board of Commissioners during the summer of 2007.

The Avon Hills Initiative is cooperating with the Healthy Community
Partnerships (HCP) in St. Joseph, Avon, and Cold Spring as well as the
Healthy Township Partnership from
Collegeville Township to ask for
\$10,000 from the Initiative Foundation.

If the funding is received as expected, much of it would go towards a paid, part-time position to assist in accomplishing Avon Hills related activities. These would include:

- Work with Allan Davisson and Steve Plantenberg to do internet and library research on comprehensive land use plans and ordinances from around the country that could be modified to fit the needs of the citizens of this area;
- Preparing drafts of comprehensive land use plan and ordinance lan-

guage that could be presented to the appropriate Stearns County and Township boards and officials;

 Assuring strong two-way communication and idea gathering from the citizens of the Avon Hills through local meetings, news releases, and newsletters.

Since funding is not yet assured, no definite timetable has been established. The position will just be parttime and would not have any additional benefits. We are looking for someone with a passion for the goals of the Avon Hills Initiative and maybe 8 hours a week to work on these goals.
