ABSTRACT: Collection contains records of the Dean of the College of Arts and Sciences from St. John's University.

SCOPE AND CONTENT NOTE: The collection includes minutes, correspondence, reports, statistics, and financial records. Frequent topics include academic departments, faculty development, curriculum, and scholarships.

ADMINISTRATIVE HISTORY: When the office of the Dean of the College of Arts and Sciences was established in 1921, St. John's University included the Seminary, the College, and the Preparatory School. The Abbot was the President. He was assisted by the Rector, also called the Vice President. The Dean of the College was therefore responsible for a division of the University, and particularly for its academic program.

In 1979, the office of the Dean of the College was split from that of the Vice President for Academic Affairs. The Dean's responsibilities included overseeing academic advising and freshman Colloquium, coordinating faculty assignments, and making recommendations about faculty hiring and promotion. Academic Deans have also been involved in planning curriculum and conducting assessment. The Deans have been:
